Payment Method

1. The room reservation will be held for a maximum of **48 hours** from the request.
2. To confirm the date, a **€50 deposit** must be paid at the Ludomon premises.
3. The remaining amount will be paid on the day of the event.

NOTE: In case of cancellation of the event by the client, the reservation fee **will NOT be refunded**.

If the client wishes to change the date or time, the event will be rescheduled if possible, **but availability is not guaranteed**.

Duration and included services

Each reservation includes:
3 hours of play in the facilities.
Snack: 1 individual snack and 1 drink.

Specific rules

Piñatas are not allowed inside the premises.

Confetti is not permitted.

Alcoholic beverages and narcotic substances are prohibited.

Food must not be taken out of the birthday room.

Supervision of minors

1. Minors must be supervised at all times by parents, guardians, or responsible adults.
2. The establishment does not act as a daycare nor assumes custody of minors.

Liability and use of the facilities

1. The client agrees to make proper use of the facilities, furniture, and materials.
2. The client will be responsible for any damage caused by event attendees due to improper or negligent use.

Schedules

1. Late arrival will not entitle the client to an extension of the contracted time.
2. Failure to comply with the exit time may result in an additional charge.

Reservation conditions

Food brought by the family

1. Food and beverages brought from outside are the sole responsibility of the organizing family.
2. The establishment does not handle or control external food and cannot guarantee its safety or allergen content.
3. The organizing parents must inform guests of potential food-related risks and supervise consumption.
4. The establishment is exempt from any liability for allergies, intolerances, or incidents arising from external food.

Food provided by the establishment

1. The products offered come from authorized suppliers, with ingredient and allergen information available.
2. The organizing family may request the complete list of ingredients and allergens prior to consumption.
3. Parents or guardians are responsible for communicating any food allergies or intolerances.
4. The establishment is not responsible for allergic reactions that were not previously reported.

Data protection

1. The personal data provided will be processed in accordance with Regulation (EU) 2016/679 (GDPR) for the purpose of managing the reservation and this contract.
2. The data will not be shared with third parties and will be kept only for as long as necessary to manage the service.


